By signing this adoption agreement I am agreeing to the following terms.

- 1. The adoptee will pay the full balance of the adoption fee
- 2. FSPR will supply the adoptee with all paperwork associated with the animal and the adoption within 7 days of receiving the full adoption fee and all required forms.
- 3. FSPR will transfer the animal's microchip to the adoptee within 7 days of receiving completed forms and full adoption fee.
- 4. If the adoptee fails to pay the adoption fee within 24 hours of completing this application form, FSPR reserves the right to terminate the adoption and have the dog returned to FSPR care.
- 5. The adoptee agrees to adhere to the animals feeding schedule or a suitable replacement.
- 6. The adoptee agrees to adhere to the parasite treatment including products used and schedule or suitable replacements.
- 7. The adoptee agrees to provide the animal with adequate food, water, shelter, love and Vet care for the remainder of its life.
- 8. The adoptee understands that animals rehomed by FSPR are done so with the sole intention that they be a domestic pet and the adoptee agrees to adopt with that sole intention.
- 9. The adoptee agrees to seek out and abide by all local council law regarding animal ownership. Dogs will be contained in a secure yard and cats will be kept inside at all times unless a suitable secure outdoor enclosure is used. The adoptee understands that it is their responsibility to register any animals through local council (if required) once adoption is formalised.
- 10. If for any reason after the animal is adopted formally, the adoptee cannot continue to provide for or care for the animal the adoptee agrees to notify FSPR and offer them the opportunity to take the animal back into care. If FSPR takes the animal back into care, the adoptee will be required to sign a surrender form and is not entitled to have the adoption fee refunded.
